## **Reports:**

# **Treasurer Report - Rich**

Overall fiscal condition is strong.

## September:

- We received 107 Contributions totaling \$11,031
- Collected \$364 in the Assembly 7<sup>th</sup> Tradition basket
- \$840 in revenue from the sale of Literature and Grapevine materials
- Total revenue for the month of \$12,238.
- Expenses totaled \$5,986
  - \$972 in Officer expenses
  - \$1,500 for our monthly Office Rent
  - \$650 in Tech and Website costs
  - \$774 for the printing and distributing of The Link
  - \$1,340 for interpretation and translation services being the major items.
- Net surplus of \$6,253 which increased our available cash balances to \$76,430.17.
- Prudent Reserve held steady at just over \$127,000 or 10.55 months, and we had \$6,000 in "seed money" in both our Convention and Special Event accounts.

Motion to accept September financials 66 approved, No opposed, 1 abstention September report passes

#### October:

- Received 96 contributions totaling \$10,779
- Collected \$108 in the 7<sup>th</sup> Tradition basket at the October Committee meeting for total revenue for the month of \$10,909.

- Total revenue for the 10 months of the year to date to \$115,790 which is 94% of the total budget for the year and approximately \$13,000 or 12.5% above the projected budget amount for the 10 month period.
- Expenses for October totaled \$3,450 and were again well-controlled and significantly below budget.
  - \$456 in Officer and Committee Chair expense
  - Our monthly Office Rent of \$1,500
  - Technology and Website costs totaling \$406
  - o \$765 for the printing and delivering the October issue of the LINK
  - Annual fee for our P O Box of \$146.
- Net income for the month came to \$7,460 bringing total net income for the year to date to \$65,904 and increasing our net cash balances to \$83,888.
- Our Prudent Reserve balance of \$127,109 (10.55 months) and the \$6,000 balance in both the Convention account and Special Events account remained steady.

To summarize, revenues continue to exceed budget while expenses remain significantly under budget due to the ongoing effects of the COVID -19 pandemic on our in-person meetings, travel and service activities. Some of these funds will be spenton the upcoming Joy of Service Workshop, a new service project by our Accessibility and Treatment Facilities Committees, and the potential purchase of additional tech equipment. Lastly, these excess funds will provide a potential safety net as we move forward with planning for the SENY Convention in this uncertain environment.

- I attended the Hispanic Districts Asamblea on Sept 19 in Queens and distributed GSR kits ordered from the GSO. At Toms request, I also inquired about their meetings and discussed the meeting guide app with them. The RSGs took the information back to their groups for discussion. At the Asamblea in October the overwhelming response was to add their groups meeting information. We are working on accomplishing that. I also distributed the Spanish copies of the 71st General Service Final Conference Reports.
- On September 19, I attended the Intergroup Liaison meeting where I picked their brains about transitioning the Hispanic meetings to the meeting guide app.

Knowing that the DCM is fulfilling their commitment and is very active I ask that before considering doing something so drastic, that all GSRs be fully informed as to the responsibilities of your DCM. Please read the qualifications, Duties, Term, Eligibility and Election Procedures on pages S32-S33. More importantly, please read the main reason why a DCM may be asked to resign their position. Our 4th tradition states that "Each group should be autonomous except in matters affecting other groups or A.A. as a whole." If someone suggests there is a problem; all GSRs in that district should investigate and not take the word of one person as being accurate or fully informed. There should be thorough discussion and consideration. Our literature discusses "contempt prior to investigation" and "principles before personalities." As trusted servants of our fellowship, we should try to make ourselves as fully informed as possible before making decisions so we can make the best decisions. I am still available for group inventories. Thank you all for allowing me to serve Area 49.

AAWS Finance update (thanks to our NE Regional Trustee Francis, GSB qtrly mtg was last week): Jan 1 – Sept 30, 2021: current fiscal year is 75% complete. Rough, unaudited #s from GSB against 2021 Budget (71<sup>st</sup> GSC Final Report, page 126): Contributions are at 74%; gross Literature sales 76%; overall Expenses 73%. Amazing budget performance: yes. Self-supporting? We're counting on \$5.6M in Gross Profit from Publishing this year. My personal definition: if we were truly self-supporting regarding our AA Services, we could sell our literature at cost. The Fellowship will have to answer that question for themselves. The Prudent Reserve is being built back up, currently at about 8.5 months of the current budget – optimal target range is 9-12 months, see 2021 "Around the Picnic Table" slideshow, page 49 (just ask, I'll email you a copy).

International Conventions / Regional Forums: 351 theme suggestions rec'd for 2025 Int'l Conv in Vancouver, Trustees will ultimately decide on the theme. // IC/RF Conference Committee will likely continue discussion re how to close the Int'l Conv (Lord's Prayer, Declaration of Unity, 3<sup>rd</sup>/7<sup>th</sup> Step Prayer, etc.). Still no survey per the Committee Consideration, but it may be in the works.

<u>Grapevine / La Vina</u>: upcoming GV topics: Prayer and Meditation; Remote Communities and the holidays; Day Counters; Getting through Tough Times; and Emotional Sobriety. Upcoming LV topics: Family Matters; Acceptance; and Newcomers. Top three selling GV books y-t-d: Emotional Sobriety, The Language of the Heart, and Voices of Women in AA.

<u>Proposed Agenda Items for 72<sup>nd</sup> GSC</u>: GSO staff still sorting through (some are "multiple motions" vs. "clear and concisely worded motion"). CPC Conference Comm will have three, including the one SENY approved at our Sept. Assembly. Total Proposed Agenda Items under consideration: 170. Of the 170, ~80 (or ~47%) seek to rescind Advisory Actions of the 71<sup>st</sup> GSC (yes, some are apparently duplicates – this year's Conference only put forth 49 Adv Actions). EDW = Equitable Distribution of Workload. The Trustees and GSO are currently working to determine what additional items will go to each Committee (primarily, but not exclusively, from Literature).

Speaking of the 72<sup>nd</sup> GSC: it will take place from April 24<sup>th</sup> to 30<sup>th</sup>, 2022. It is currently scheduled to be held <u>in person</u> in Brooklyn, subject to the state of the pandemic at that time. Please consider serving on the Conference Hospitality Committee!

Our Area 49 Delegate's Questionnaire will look a bit different than in years past. I will tell you more about it... at our next Area Assembly on January 23<sup>rd</sup>.

2022 NERASAA in Pittsburgh/ PA area, it is currently scheduled live, more will be relieved - once i have it i will let you know.

Finally, I'd like to read several quick bits to you [Tradition 1, short form; Tradition 1, long form; Declaration of Unity; and Language of the Heart, page 77]. The last few years, principle has come to the fore: "people all want and need to be heard". Conference: weeklong business meeting, debating in love of A.A. One of the "What's New" items in the beginning, letter from

Bob W [read from page 1]. We can disagree – we're drunks, we often will – but let's remember to respect and love one another. We're all on the same road, with the same primary purpose.

- We need to think as a fellowship...
- Try to approach conversations by saying something like: This is what I'm hearing you say, here's how I feel. Is there a way we can reach a compromise. ← It's not always going to work.
- "Take cotton out of ears, and put it into your mouth"
- As an AA member, I need to acknowledge other people's view, and think about if we can find a compromise.

### **Exploratory Committee Chair - Heidi:**

For In-Person Events:

- MASKS required
  - New York State has adopted the CDC Guidelines regarding COVID-19. The CDC recommends masks for all people, regardless of vaccination status, while indoors, and New York's law is consistent with this.
  - o Before the Delta variant, it was recommended that only the unvaccinated wear masks indoors, and masks were optional for the vaccinated. It was our position at that time that we, SENY, do not want to have to be in a position to have to collect the vaccination status of people who are doing service and coming to events, if at all possible, so our recommendation even at that time was that masks would be required for all for in-person indoor events.
  - o This is subject to change, of course, based on a new law or executive order.
  - o We are recommending masks for all in-person events.
- SENY will provide surgical masks and hand sanitizer at in person events.

#### VENUE

- o Because we want to avoid having to collect vaccination status for larger in-person indoor events, we are recommending looking at facilities outside of the 5 boroughs for such events. NYC has much more stringent requirements than the state and as we read them, would require SENY to collect vaccination information from attendees.
- o Venues should have adequate washing facilities.

#### SOCIAL DISTANCING –

- o We recommend in addition to mask-wearing, there be capacity limits to the extent possible to provide for social distancing.
- o We also want to limit, to the extent possible, close contact between people so we are discussing what this would mean for service tables and registration. Outdoor registration, for example, would make the most sense because the outside is ventilated but that is not the solution when it comes to inclement or cold weather so we are still discussing indoor recommendations for that.

## <u>Limited eating and drinking and only in designated areas</u> –

- o It is important that people wear masks at all times.
- o We are recommending that for shorter events, such as committee meetings, no eating or drinking be permitted indoors.
- o For longer events, we are recommending that eating or drinking take place only in designated areas. SENY would not be preparing meals, so it would be a bring your own brown bag situation.
- CONTACT Always ask before hugging, shaking hands with, kissing, or touching another person, and when in doubt, no touching.

#### PRE-REGISTRATION -

- We also suggest pre-registration for all attendees so that these requirements are known in advance by anyone who wishes to attend an in-person event. This would also help with contact tracing.
- COVID-19 Positive Test –

- o We are recommending that any person who attends an in-person event and tests positive for COVID-19 let the Chair or her designee know so that they can notify those who attended that someone tested positive.
- In a nutshell, our recommendations are to wear masks, social distance to the extent possible, and eating/drinking only in designated areas.
- We are still working out service tables/registration recommendations.
- All of these recommendations are subject to change based on 1) the law and 2) whatever the venue's requirements are. Our position however is that where the venue and these recommendations differ, the stricter of the two be used.

## Hybrid Assemblies/Committee Meetings:

- We believe that SENY's ability to engage in service remotely is here to stay. It is
  important that people who have accessibilities issues or have reasons why they do not
  feel safe coming to in-person events or are not able to comply with these
  recommendations be able to participate in service. Hybrid Assemblies and Committee
  meetings are the way of the future!
- Static Location There are many tech requirements needed to bring this to fruition. To this end, we are looking at having a static location for the in-person aspect in a central location.
- Tech and Other Volunteers Needed: Now, we have priced out a list of things SENY would need to purchase to make this happen. However, that is not the big issue. The big issue is that for the last 20 months, we have relied on our Tech people to keep our homegroups open, make SENY assemblies and committee meetings happen, and a wide array of many other things. The ones who have taken this job on are exhausted. To really have hybrid meetings be a thing for the future, we need volunteers with tech experience to step up to the plate.
- We also need other volunteers to help with the in-person aspect of events such as handing out masks or sanitizer, etc.
- Please step up to the plate to be of service!

Q: Will there be a workshop to train people who want to help but aren't' tech savvy
A: We have not discussed this, but certainly something we can discuss at our next meeting.

Q: Have you discussed wifi at these venues?

A: Depending on the venue, wifi access is hit or miss. We don't want to rely on venue wifi. On the list of things we would have to purchase are several hotspots

Q: Would hybrid meetings mean in person with virtual meeting?

A: yes - it would bring it together. The vision is having large screens for virtual participants, but we have to figure out what translation would look like. We would want an assembly where virtual and in person can participate equally.

Q: BKLYn county supplies buses to take GSRs to assemblies. Has there been any discussion on this?

A: We haven't discussed this, but we can definitely put this on our agenda.

Q: How would you protect anonymity? If you go to in person

A: We have discussed where cameras are, we have discussed large TV format... To my understanding we are not anonymous to each other, so we are careful how we name ourselves

Follow up answer: We don't let anyone into our meeting... you need a passcode and we also require you put what meeting you are from etc.

Further discussion: what's the difference between showing your camera and walking into a camera

Q: What if other people walk by in the background and look at someones screen? Ex. Other people in peoples home walk by the camera.

#### TCO Chair - Mike - min 24

- Tech resources: Has significantly gone down. Area tech committee is down to 8 people.
- How to better develop Tech services? We need to think about developing tech servants further up the triangle. I would like DCMs, GSRs, to think about people that might be interested. We want to develop a talent base
- Think about the need for this to be permanent in AA.
- Fellowship connection: GSO continues to make slow improvements to fellowship connections. Justin is working very hard with Air Table and Fellowship Connection.
