Good evening / Buenas Noches...

Thank all of you for making yourselves available to serve Area 49 and its Counties, Districts and Groups. Time to apply "let's get to work."

SENY and A.A. at a tipping point. Opportunities over this rotation so that A.A. becomes stronger and more vibrant than ever. Fellowship is a "we" program, SENY Committee is a "we" effort.

Primarily addressing DCMs and DCMCs tonight – focusing on the Service Triangle: Districts and Counties.

Groups have reacted to pandemic in different ways, often withdrawing from service below the group; all dealing with it as best they can.

How do we bring the Area into whatever the "new normal" looks like? Going to take hard work, persistence, and imagination, on the part of DCMCs and DCMs.

AA Service Manual / The District and the D.C.M. / Duties (on page S32): "Receives reports from the groups through G.S.R.s *and through frequent personal contacts with groups in the district.*"

Difference for a GSR between just doing a job and being motivated.

DCMS, DCMCs and Committee: lead with the question "what can the district / county do to serve your group?", rather than "why don't you come to our district meeting?" Helping hand better than "should"; redefine service. Help the groups understand that general service is relevant: offer to serve them.

My part: second half of 2021, two primary focuses. 1) report back on the 71st GSC to every County and District possible, and 2) serve and support the SENY Committee. And don't forget the Past Delegates who want to serve the Area and its groups as well - they are part of this Committee, too.

Two additional challenges tonight: Contributions and Rotation.

Contributions: collective officers, Panels 69 & 71 voted to contribute \$50,000 down the triangle to GSO. Rationale of why we did that. Tradition 7, Long Form, "...A.A. treasuries... accumulate funds for no stated A.A. purpose". Current prudent reserve represents about 10.5 months of 2021 budget. Direct questions to one of the Area Officers.

Regarding Rotations: Section 8 of the Current Conference Charter of the U.S. and Canada. "*Area Assemblies, Terms of Office for Group General Service Representatives, Area Committee Members and Delegates*: unless otherwise directed by the Conference, these terms of office shall all be concurrent and of two years' duration each." "Each group should be autonomous except in matters affecting other groups or A.A. as a whole."

Start looking at the next three months. Pass this part of my report on to those you serve. Next SENY Committee meeting April 5th, next Area Assembly (Pre-Conference) April 10th, lots of ground to cover.

- NERAASA – February 26th through 28th – virtual, registration fee \$21. For every A.A. member, involved in service or not. neraasa.org to register.
- The SENY Convention – March 5th through 7th – virtual, registration fee \$20. oaseny.org to register. Support your Area's Convention.
- Saturday, March 20th – virtual, Delegate's Day of Sharing. Delegate's Questionnaire 7-10 questions, agenda items to stimulate interest & discussion in groups. Timing of DQ release tricky, short timeframe.
- Saturday, April 10th – virtual, Pre-Conference Assembly. Best time of the year for the group's voice to be heard. Please urge attendance.

I need contact info. Need to discuss 2021 hard-copy Final Conference reports very soon – will only be ordering 400-600 in English.

Hello everyone my name is JoAnn and I am definitely an alcoholic, privileged to serve as Area 49's Alternate Delegate. I want to welcome everyone to the Committee meeting, especially the new trusted servants to service.

The alternate delegate is the assistant to the delegate and the most important responsibility is to be available and prepared to attend the General Service Conference if the Delegate is unable. As stated at the Assembly, I was also honored to moderate at the NYCPAA group Inventory Meeting a few weeks ago. I attended the first Service Sponsorship committee meeting on January 24th. The first Service participation meeting will be on the third Thursday of February which is February 18th. I will send the meeting information out to the DCMCs this week. The meeting is normally held on months where there is not an assembly. I have begun thinking about another responsibility I have which is organizing the first of the two Joy of Service Workshops. I would hope to have it virtually within the next few months. More details to follow since I need to check the calendar for a good time to have it. Last week I attended the NERAD (North East Regional Alt Delegate) meetings which are chaired by our Northeast Regional Trustee and held twice a month. We are beginning to receive information about the upcoming General Service Conference. So far I have been asked to moderate a couple of group inventories and I am looking forward to it. I welcome more invitations to County and committee meetings. Thank you!

Treasurer- Rich

Hi everyone! My name is Rich and I am an alcoholic and I am honored to serve as your Panel 71 SENY Treasurer. I hope you are all well and safe.

This report will be a little unusual as we will not be presenting a full financial report. Since it is only February 1st, I haven't been able to complete the January financials because we haven't been able to reconcile with the bank yet and are only just receiving the January bank statements. Instead, I'll present you with some preliminary numbers as we know them. Also, the approved 2021 budget is posted on the temp page in case you missed the January Committee meeting and Area Assembly where it was adopted.

The highlights for January – We began with a bank balance of cash available of \$21,144. We received a total of \$15,050 in Contributions from groups and 7th Tradition. We paid normal monthly expenses for rent, storage facility, tech expenses, etc. We also paid \$1500 in printing bills (3 invoices) and \$3,000 to the General Service Board for our Delegate's Conference Fee which was the total approved in the budget. Our bank balance at January 31st was \$32,643.17 and we had net unposted items of approximately \$3,900 so our actual balance if everything was cleared would be about \$28,700. Our prudent reserve remained at \$127,000 and change.

So, we are off to a good start – contributions are coming in and all our bills are paid. Once I reconcile with the bank statements in the next few days, I'll send out the full January Financial Report to all the Committee members. Feel free to share it with your GSRs and areas as you see fit, but please be reminded and remind them that this is a *confidential report and should not be posted or displayed on any public forum*. We also completed just about all of the logistical tasks

necessary to allow us to move forward – most notably meeting at the bank to update the signing arrangements on our checking account and updating the records for our PO Box at the Post Office so the proper people have access. So far I have been traveling into Manhattan weekly to empty the box and that looks like it will continue to be the plan moving forward. I also attended a NERAASA Inventory review meeting and will be attending NERAASA 2021 in February and our SENY Convention in March. Since we will hopefully be shifting into high gear and starting our service work, I will also be sending out copies of the revised Spending Guidelines and a copy of the Request for Reimbursement form to the Officers and Committee Chairs.

And once again, I would like to thank JoAnn for all the help she has provided to me and continues to give me. Thanks Jo!

County registrars have been trained; however, we are making some updates to AirTable and Mailchimp to simplify the process, as both have improved tools since we adopted them. We are looking into our data retention practices, as we are keeping information on individuals who are no longer in service. I will report back before we take any action. Our email update editor, Sam, had to step down for personal issues, and if anyone is or knows someone interested in the position, please reach out. Claire is creating standing committee pages on the website, although the process is taking longer than anticipated and may take several months. We are also looking into improving the Spanish-language materials for the website, with the hope of achieving parity. Lastly, we have not yet been able to fill the position of postal mailing coordinator.

You can now register for the 2021 Convention on the aaseny.org website. The cost is \$20 and you will need to register to receive the meeting ID's and passwords. We need people to register as soon as possible for our planning. We want to be sure that we have licensing so everyone that wants to attend the convention will be able to. The event flyer was mailed to all GSR's last month and is linked on the SENY website.

The program committee has requested tech teams as well as speakers from each of the counties and service committees. If you would like to be a part planning, the program committee will meet next on February 7 at 4:00-5:30 PM. The meeting ID is 894-7649-3438 and the password is Starship.

Thanks to Putnam County, Westchester County, Bronx-Upper Manhattan, Nassau County, Hispanic District for responding to our Program chairperson, Keith's request to provide personnel for your meetings. We are still waiting to hear from

the remaining counties and the service committees. I think treatment and corrections have talked to Keith, but we still need the host and co-host contact information. The training will be this Saturday between 2 and 4pm. Part of what we are paying for is this training, it would be great if your hosts and co-hosts could attend.

We continue to need Tech Volunteers. These are the people that will host and co-host meetings that are not put on by a county or committee and floaters where needed. If you host a virtual AA meeting, you are qualified to be part of that team. If you would like to learn how to host or co-host a virtual AA meeting, you are welcome to be part of the team. Our February 6 meet & greet, and training session will provide the tools to do the job we're asking you to do.

Our volunteer coordinator is John L from Putnam, contact information is 203-482-2595 email jplivz@yahoo.com please sign up or let him know if you are willing to be available for the weekend of the event and some time for training prior to the event. The flyer for the Tech volunteers is linked to the convention web page with an electronic signup sheet.

I have had a few people ask me why there is a registration fee for a virtual convention. This is what I have told them: Thanks for the question. I originally went to SENY and asked if they would provide the funds to cover our expenses. I was reminded we are self-supporting, and the groups did not send contributions to SENY to pay for the convention. As it stands, with a \$20 registration fee, we need 350 registrations to cover the expenses. The tech expenses include special workers for training sessions and support Friday, Saturday and Sunday, licensing for virtual meetings. We printed flyers and did a mailing to the counties, there are fees involved using online registration acceptance of credit and debit cards, costs for both Spanish and ASL interpretation, and there might be entertainment expenses. We got the tech expense down quite a bit by asking for tech volunteers. We are counting on around 40 volunteers which gave us a significant reduction from the cost we were quoted originally.

So far, we have 190 people registered. Our publicity team plans to make an extra effort to get the word out with email blasts. **But this is your convention.** We need you to go back to your counties and talk up the opportunity to attend the first ever Virtual SENY convention and to be a tech volunteer.

If you have never been to a Convention, now is the time; Let's get this party started! Any questions?

I attended the SENY Area Treatment meeting and the Brooklyn County General Services meeting - both on the 27 th . Participants expressed a collective interest in providing greater access to AA resources for individuals who face challenges related to technology (the “Digital Divide”), remote geographical access (which includes institutionalization), and/or physical limitations. One Committee member is looking into providing virtual meetings to alcoholics in prisons, and to young alcoholics who are in rehabs. Another Committee member is composing a survey designed to gain information about the accessibility challenges faced by alcoholics, and suggestions as to how we may be able to help provide greater access to the benefits of AA.

In addition, lack of diversity at certain AA meetings was cited as a possible indicator of inaccessibility. Of particular interest is a desire to assist older members of AA. One plan we may pursue involves distribution of The Grapevine to people who have difficulty accessing AA meetings.
