### Treasurer's Report - Rich S. - <u>treasurer@aaseny.org</u>

#### June

- Received 89 contributions totalling \$7,347.
- Literature sales and the 7<sup>th</sup> Tradition baskets from the Assembly and Committee meeting increased total income for the month to \$7,884.
- Our expenses totalled \$5,130 with Officer reimbursements of \$457, Office rent of \$1,500 and the annual premium for our insurance policy of \$1,903 being the major items.
- Net surplus for the month was \$2,753. This increased our cash balance to \$47,237.
- Our Prudent Reserve stood at \$127,101 or 10.55 months.

Motion passed to accept June report. 88 people in favor, 6 abstentions, no opposed.

## July

- Revenue of \$9,076 consisted solely of 76 group contributions.
- Expenses were just under \$6,000. Monthly Office rent of \$1,500, \$2,618 for translation and interpretation services, \$480 for printing and mailing the LINK, and \$470 for travel expenses for the Corrections Chair to attend the National Corrections Conference were the primary costs.
- The net surplus for the month of \$3,083 increased our cash balances to \$50,318. The Prudent Reserve remained constant.

Motion passed to accept July report. 105 people in favor, 4 abstentions, no opposed.

## August

• We received 90 contributions which totalled \$16,723 and collected \$150 in literature sales. We also received a transfer of \$6,376 which was the profit realized on the 2021 Virtual SENY Convention bringing total revenue to a monthly high of \$23,252.

- Expenses declined to \$3,388 with monthly rent of \$1,500 being the largest expense. We paid \$500 to District 620 for the use of their storage facility where we have kept our Grapevine/La Vina inventory since January. We have since rented our own facility where the materials will be stored going forward. We also paid \$200 as a fee for the use of the facility where our Tech Committee co-sponsored the Hybrid Meeting Workshop. The net surplus for the month rose to \$19,864 and allowed our operating cash balances to increase to \$70,180.
- Our Prudent Reserve held steady at \$127,105 or 10.55 months.

# Motion passed to approve August report. 112 people in favor, 1 against, and 3 abstentions

- In short, we are outperforming our budget with revenues exceeding the budget on a year to date basis and expenses well below the budget projections. Contributions for the 8 months were \$81,820 or approximately \$6,000 higher than expected. Our 7<sup>th</sup> Tradition baskets, literature sales and the SENY Convention surplus increased total income to \$90,104 which is 73% of the total budgeted for the entire year.
- Expenses for the 8 months were minimal at only \$40,450 due to the continuing effects of the Covid-19 shutdown which is only 42% of the expected amount at this point and 28% of the total budget for the year. We had budgeted assuming that we would be virtual for the first six months of the year and back live for the second half. This has not happened so our Officers' and Standing Committee Chairs have not been traveling or spending much of their budget and we have had no real expenses for our Assemblies and Committee meetings.
- We are doing very well but these unexpected surpluses will create a question which we will need to discuss as we move forward –what to do with these excess funds.

I'll be sending out budget worksheets to the Officers and Committee Chairs soon (probably in early October) so we can begin to work on the 2022 budget. In the meantime, I continue to encourage them all to seek out ways to utilize their budgets and provide services and support to the SENY AA community.

### Technology & Communications Officer (TCO) Mike O. - tco@aaseny.org

According to GSO there are around 1,452 active groups in Area 49. Obviously, we do not have fourteen hundred GSRs present. However, Concepts 1 and 2 state that the final responsibility for AA world services is the collective conscience of our whole Fellowship, as decided at the General Service Conference. As a GSR you are your group's voice and conscience in the general service conference process, today deciding what we as an Area would like the Conference to consider. Your presence and participation ensure that your Group's conscience is heard!

Tech committee did not meet in July, August, or September. But, the committee and Putnam County put on a well-received and well-attended workshop on holding hybrid meetings. Written materials are on the SENY website tech page.

I attended the virtual NYS Information workshop, where I presented. I also attended NERAASA; I will attend the virtual National AA Tech Workshop next weekend.

We've begun the process of translating SENY documents into Spanish, starting with how we run our meetings; translated copies are in the temp folder for today, and will be added to our website shortly. More documents will follow, including the service manual in Spanish and other conference-approved documents such as the concepts and traditions checklists, plus service pamphlets. GSR Kits and data storage: Over the spring and summer Justin and I participated in a number of registrar meetings with GSO and other Area registrars. As discussed in this month's Box 459, GSO now uses Oracle NetSuite, which GSO calls Fellowship Connection, formerly MyPortal, for all data and transactional purposes. By whatever name, GSO's systems were originally designed for GSO staffers, to carry out GSO purposes; Area access was limited to registrars only, for the purpose of updating information.

In recent years and with Netsuite GSO has set a goal of expanding access to Fellowship Connections to DCMs to facilitate service. That has its own set of difficulties, in that the system, originally designed in the early 1990's, was not set up for that. Data flowed in, not out. GSO is trying to correct this, but the process is laborious.

That said, during this process it's become apparent that Fellowship Connection contains a lot of bad data. For example, in Area 49 Justin found a number of groups who, according to GSO, have had the same GSR since at least 1977. I looked at Districts: GSO believes there are 208 Districts within SENY; the real number is less than 100. My personal favorite is District 43, whose geographic borders are limited to a 2-bedroom condo in Pomona, Rockland County. For the good of the Area and GSO, we need to help GSO clean this up. Justin has reached out to GSO for further guidance on how to correct or delete bad data and we will be asking for the DCMCs and DCMs help in this process. In the meantime, if you have not received a kit and want one, please email me at tco@aaseny.org – the address is in the Link.

Lastly, because of how data flows in Fellowship Connection, if you are a new trusted servant or need to alter or add Group information, please use the SENY website. It's faster and far more efficient than GSO.

I am available to speak on the traditions or concepts or my service commitment.

#### **Questions Summary**

Q: 1400 groups in our area. Do you feel like our group conscious of our area is brought to assembly and general service conference? Right now we have 188 people on this call A: Tom answers this:

- A few years ago, for panel 67 we had graphs etc, tracking this kind of stuff. We had a generous avg of 12% of the groups. What about the rest of 88% groups? We do everything we can. We have a very robust website, we send out an email blast, Tom is open to suggestions on how to reach out to these groups.
- From experience when Tom went around to dark groups in Suffolk a lot of the responses were: "we are all set thanks, thanks for coming by."

- All of us reaching out is a lot more powerful, than just Tom reaching out.
- Tom would love to know what all those absent people think when headed to conference

Q: Looking to outreach in virtual meetings. Is there a possible way to reach out to those meetings?

There is no final date yet on the release of the printed 2021 Final Conference Reports; as soon as I have them I will distribute them to your DCMCs. Each DCMC will have a certain number of reports, based on what they told me in the spring.

The new A.A. General Service Manual will be available within the next month or two; I encourage EVERYONE in service to obtain a copy as soon as possible.

As currently scheduled (and pending the pandemic situation seven months hence) we are scheduled to hold the 72nd GSC on April 24-30, 2022 in person, at the Brooklyn Bridge Marriott in Brooklyn. If that holds, we need volunteers for the hospitality committee, which is geared towards visitors coming into town with the Delegates. I did this in 2019, and it was a wonderful experience. New business: five motions, each a proposed agenda item for next year's 72nd General Service Conference. These have been submitted to SENY for consideration, discussion, and vote by you, the SENY Assembly members.

I am asking you to consider each motion as it's presented, and hold it up to your understanding of our AA Traditions, and the understanding of your group as well. I'm going to ask you to honor the two equally important parts of Fellowship discussion: speaking with conviction (but never with anger or disrespect), and at the same time listening with open-mindedness. If we consider and discuss in that spirit, and in the spirit of the readings I just gave you from Bill W and Dr. Bob, then the voting will take care of itself.

## **Questions Summary**

Q. People putting down conference approved literature other than the BB. How do we go about this? How do we approach people about this topic?

A: The best thing for people who don't understand, is education. I am most willing to listen when I need to be educated, especially when someone is using the message of love and service

that Dr. Bob talks about. From Tom's personal experience: It is better when these types of conversations are had one on one versus in a group setting. One of the standard questions is to ask "is your group's GSR aware of what's going on in General Service? Maybe your GSR can bring back some information around this issue?" With tolerance, suggest to talk after the meeting and before the meeting and be ready with examples of how other literature is important besides the BB.

Q/A: If you are the GSR for 2 different groups, you cannot vote separately. Each group should have 1 GSR, and then 1 vote.

Q/A: If you need to sign up for an area and you are a virtual group, reach out to registration@aaseny.org or TCO@aaseny.org about registering.

Q: Instead of Tom going out to all the groups, why don't GSRs, DCMs, DCMCs go out to dark groups?

A: According to the Service Manual, it does deputize the DCMCs, DCMs, GSRs to help the delegate carry the message. The delegate can't do everything. Oftentimes, Tom reaches out to DCMs, etc to help him out, he needs help.

Q: Should GSRs have known these motions prior? Should we have discussed these motions with our groups before the meeting?

A: Yes- this has been on the website since Aug 25. We encourage people to check our website on a regular basis. If you missed the window to submit to SENY, you still have until Sept 15th to submit a motion directly to GSO.

[Title] Are there other types of Spiritual Leaders who might Cooperate Effectively with A.A.?

There are numerous leaders, lay members and spiritual servants who are in a unique position to identify those who may be suffering from alcoholism, and can direct them to A.A. Included in this group are those who do not identify with specific religious affiliations. For example, Spiritual Directors and Pastoral Care Providers offer spiritual guidance, both one-on-one and within important institutions such as hospitals and prisons. Many spiritual care providers serve humanists, agnostics and atheists. By any name, those who offer a solution based on spiritual

growth can direct those they recognize and serve, who might suffer from alcoholism, to the spiritual program of Alcoholics Anonymous.

Motion is seconded. 2 min discussion Robust discussion took place.

Vote: 121 Yes 13 No 10 Abstentions Votes determining percentage: 134 Total votes: 144 <sup>2</sup>/<sub>3</sub> - would need 90 in favor *Motion carries*

**Motion 3:** I make a motion to keep the 12 and 12 book exactly as Bill wrote it wrote it, as a historical document in the same respect as the 1st 164 pages of the big book of Alcohol Anonymous.
