## **OFFICER'S REPORTS**

## **DELEGATE'S REPORT** (Jane E)

DDoS Information: At the time the date of March 16<sup>th</sup> was set, the NYC parade was set to be on the 17<sup>th</sup>. Regrettably, since then, NYC has changed the date to the 16<sup>th</sup>.

One of the standing agenda items for the Treatment/Accessibilities Conference Committee is to review: a) draft of proposed Remote Communities Kit, b) contents of Treatment Committee Kit and Workbook and, c) review contents of Accessibilities Kit and Workbook. The kits are on display here, and the letter from GSO to Jane E. was read out loud. Background information on the GSC Agenda items: The full background information was sent to me, and within 48 hours I developed the questionnaire and sent the background information and invitation letters to our seven presenters. In the past two weeks, the background information has been revised three times. Fortunately, not the agenda items on the questionnaire. Because of these multiple revisions, I will wait until after the DDoS to send out full background information to the DCMCs for wider distribution. I trust that the DCMCs will make it known that it is confidential information, not to be posted on any public website, social media (including so-called secret groups), AA newsletters or published reports.

One standing committee chair asked me for the full background information, and I sent it to them and will to you, if you e-mail me, although it may be better to wait until after the DDOS for the reason of multiple revisions. Note that when you ask the following will be in my email:

"The 69th GSC Combined Agenda and Background all Committees" is confidential for AA members only and not to be posted on any publicly accessible website, social media (including "secret" groups), in newsletters, or published reports." Please do not be offended when you see that in my email; it's my job to give you that information. All of us in this room are trusted servants. As you trust me to do my job, I trust you too to make sure that the confidentiality is kept.

NERAASA Report: see our Northeast Regional Trustee's (NERT's) presentation on the bottom-left of our website's homepage. Click Northeast Regional AA Service Assembly.

Contributions: In 2018 were 82.3% self-supporting. In 2018 we are 74% self-supporting. Rationale explained (contributions flat, multiple expenses up). Reminder: AA members may contribute on a recurring basis for as little as \$5 per month but no more than \$5000 per year to help make AA self-supporting someday.

I felt wonderful about being a part of SENY. SENY members at the mic had amazing stuff to say! Delegates are not to go to the mic and are not to discuss GSC Agenda items at NERAASA, we are to listen. The Panel 68 Delegates at the Delegates' round table gave me the feeling of being a newcomer in a loving home group. Very cool.

Last rotation, the Ad Hoc Finance Committee was asked to review and update the 2012 SENY Spending Guidelines. ## **CHAIR'S REPORT** (Jerry R.)

#### **International Convention:**

**Q** Must everyone register? **A** Yes

Q How much will registration cost?

A Advanced registration for the convention between September 9, 2019 and April 14, 2020 will be \$115.00 (USD) per attendee. Registration after April 15, 2020 will be \$140.00 (USD) per attendee

**Q** Can travel agents register groups or individuals? **A** no

**Q** When can I reserve a hotel room? **A** Once you have registered for the convention, you can sign up for housing.

Q Where are the main hotels?

A Our Convention hotel block of over 10,000 rooms will be in five main areas, four in Michigan — downtown Detroit, Dearborn, Southfield and Romulus/Airport — and one just across the Canadian border, in Windsor, Ontario. Of those 10,000 rooms, only 3,000 are in downtown Detroit and within walking distance of the Cobo Center and the Ford Field Stadium.

#### Q Can members contact hotels directly?

A No. To make the process as fair as possible, all housing requests will be processed through the Convention Housing Bureau.

# Q Can travel agents make room reservations?

**A** Room reservations can only be made in an individual's name. Rooms available through the Housing Bureau, at specially negotiated Convention rates, are not commissionable to travel agents.

We do not have an Office Manager. Pablo has card for new office. He will let people in when they want to have a meeting at the office off hours (at night or on weekends). If you would like to have a meeting there, I will give you his phone number/e-mail to make sure he is available. I also have the contact info for the man at the building. Please e-mail

him to make sure a cubicle is available before putting it on the SENY calendar. Possibly have someone to make coffee at committee meetings. Need someone to set up electronic equipment at committee meetings and assemblies.
