OFFICER REPORTS

Delegate's Report

First the bad news, we were not successful in our bid for NERAASA 2021. Traditionally, the bid goes to the area that last hosted longest ago. Area 60, Western Pennsylvania, last hosted in 2002. SENY last hosted in 2011. Area 60 also had a hotel rate in Pittsburgh of \$109/night. Our bid was for \$136/night. Area 60 had the successful bid. We can certainly try again next year for 2022. And don't forget that SENY is hosting NERF the weekend of May 31- June 2, 2019!

I attended the Conference very well-informed. In addition to the feedback I received at the DDoS and the pre-Conference assembly, I received back over 400 questionnaires!!! 416 to be precise. Half online, and then evenly split between email and snail mail. Thank you again to Chris for getting it posted online, to Michael for distributing it by email, and Eddie and his team for translating it into Spanish so quickly

For tonight, I'm going to give you an update on what happened on just those 8 items:

The Corrections Committee discussed the request to create a new pamphlet for inmates who have been released after long-term incarceration and took no action. They felt current service materials could be revised for this purpose

The Conference recommended reprinting the God Word pamphlet and creating the new pamphlet for Spanish-speaking women. The Conference recommended changing the subtitle of the GSR pamphlet and making the revisions to Living Sober. The Conference did not approve a recommendation to create a new book combining the Twelve Steps, Twelve Traditions, and Twelve Concepts essays. The Conference did not approve adding the appendix about the Library of Congress recognition. The Literature Committee took no action on adding the Preamble, the Responsibility Statement, or the endnote about Dr. Bob

The Trustees Committee thoughtfully reviewed a proposal to censure the General Service Board and after seeking extensive additional input from the general manager of the General Service Office, the chair of the General Service Board, and additional General Service Board trustees, agreed to take no action. They also reviewed a proposal to reorganize the boards and took no action

It was quite an experience. I'll provide much more detail on June 2. But one thing I mention in my Link article is that I had the unique opportunity to spend 4 ½ hours on the dais and at the microphone presenting the Literature Committee's report and answering questions as the Conference worked its way through each of our 14 Recommendations and 9 Additional Committee Considerations

It truly was a transformative experience. Though I'm not sure I fully understand how it changed me. In my spiritual journey, I've figured out that I don't need to figure it out

Q&A clarified that Delegate received 416 questionnaires. New literature: there will be a call for Spanish-speaking women to share, their submissions based on guidance that will be publicized; plan right now is to have it only in Spanish. May take a couple of years. Two different processes for AA publications; literature deals with recovery, which must be conference-approved, while safety and other guidelines do not go to conference and are prepared by staff

We are hosting the 2019 informational Workshop, and there are currently insufficient funds in the Special events Account to support reserving a date at a suitable venue. (So far, Graymoor has quoted \$6500- and Stony Point \$7000- to hold the date and in addition there will be seed money needed). I've talked to our treasurer about it. Please consider how we should make that happen.

After we hear tonight's final Convention report I'll be announcing the 2019 convention Chair (both will be repeated at the Assembly). Mike of Queens has rotated into the AHFC chair position and Teri G. DCM of 608 has signed on for the rest of the year. Please help me welcome Mike and Teri.

Handbook.....here is the proof [i.e., the new Handbook]! Richie the office manager will picking up the handbooks in time for the June 2 Assembly, so people can review the job descriptions before the elections in September. It will be on the website before the Assembly in place of the old one. The AA service manual lists requirements and general job descriptions for all of AA whereas the SENY Handbook has specifics. Once it's translated and printed in Spanish I'll bring it to the Asamblea. Registrar

I want to thank everyone. I have a lot going on right now – I'm studying intensively for the LSATs, and I'm on an apartment search that seems to hit every possible snag. But I've been able to fulfill my commitment, and it occurred to me in putting together this report that a huge number of people made that possible.

When I first started, the Registrar's work existed more or less in isolation from everyone else, and it was the definition of unmanageable. Whether a Registrar went far beyond what any service commitment should require, or refused to, didn't make that much difference. Either way, the information never seemed to stay up-to-date.

When we began our experiment with a shared database system, that changed. Just over two years ago, I started to work with the Queens Registrar, instead of by myself. More counties came aboard, to the point where we now have a whole team. Many DCMs and DCMCs have gotten involved through Views. GSRs actively send in new info and reply to the automated welcome emails with their missing info. I can't remember if it was unanimous or not, but at least almost everyone here voted to adopt the shared system. And even the critics have helped – their concerns have often pointed the way towards further improvements.

Here's what may feel like an anticlimactic conclusion to those shout-outs, but I promise it's not:

When I needed extra time for my personal life the most, I was able to spend about an hour per week on average to do a solid job fulfilling my commitment as Registrar. That wasn't possible before. Based on the stories I've heard at the NERAASA Registrar Roundtable for the last 3 years, ranging from uncomfortable to horrific, that's not possible for most Areas. As we approach rotation, what previously I had every reason to believe I can now confirm through my

own direct experience: it's now possible to serve as Registrar effectively and still have a balanced life.

Normally something like that would be the highlight of my report, but the Hispanic Districts have managed to one-up it. This past month, they voted to join the shared database system. We now have all 13 counties participating. When we first started, I thought we'd be lucky if a handful joined – I like to aim high, but I never thought we'd have 100% participation.

As soon as I take the LSATs on June 11, I'll discard this unnatural state of balance, and work on getting them aboard and my other open projects. I have already started setting something up so any English updates are automatically translated into Spanish, and vice versa, so the Hispanic Districts can experience the database entirely in their own language. At that point I will be bringing their administrator onto the shared database team.

So, thank you everyone for keeping an open mind, and bearing with me, and making the Registrar commitment manageable for my successors and for me.

Recording Secretary (Mike): Thanks for sending to NERAASA; we discussed whether Secretaries should record exact votes; Areas usually do not because once that is what GSC and because group conscience is established that is what matters; it's not legislative history. I have made this change to minutes. In other Areas the Secretary reports, and the Secretary will report going forward. I wrote a LINK article; although I did not mention NERAASA it was reminder to me that minutes are important because it is what we leave for posterity, and what we are taking down is not just the group conscience but our 12th Step work

Convention (Mike): Penultimate Convention Report: first, thanks to John W and Terry F, past-delegates, for help. Although not final we had 1,054 registrations and 300 banquets. We are waiting to see if some speakers will claim expenses (some do, some do not)

Hospitality room panel (rental) was additional \$375, video screen rental was \$275, podium \$525. The big expense was loss of room block, where 547 rooms went to 476 over last few days, which cost \$3,700. Will return \$6,000 in seed money and will next roughly \$7,500. With regard to cancelled rooms, there is a way to avoid charges by using Al-Anon's method, which involves them collecting all the money, but that requires us to do a tremendous lot of work because we can't use hotel customer service for return policies.

Q&A clarified that special edition of LINK came out of LINK budget. Discussion clarified that some people, possibly even 20 or 30, use maxed cards; when they show up (or don't show up) they can't pay, and one thing is that although we would like a one-night charge when booking that's not Marriott's policy, and we are not big enough to ask for change to corporate policy

New Business

Nisaa A. is announced as 2019 SENY Convention Chair

Motion to bring up Special Events Account to \$8,000 from \$3,996 from Prudent Reserve and that Special Accounts should be restored to \$8,000 at the end of the event; **Seconded**

Discussion clarified that we use 7-9 months as prudent reserve and if we use this money we are still in window. The Special Events budget line is different from Account; the Account is not listed on budget, and this is money for future events. The Line is for funding officers like Recording Secretary to go to events like NERAASA. Special Events is funding events like NYSIW, would be NERAASA. Motion will take allow money to be taken from Special Events and then be restored when Event is over.

Motion to Postpone Debate; Seconded, Passed

After Minority Opinion heard, opinions changed; Discussion Reopened

Need to spend money to get space for events; price will go up if we delay. Treasurer clarified that the Special Events Account is different from financial reports presented by Treasurer and is funded when we have Special Events

Special Events Motion Re-Voted; Passed
